Only sound an alarm if you feel it is safe to do so. If you have not been trained in conciliation techniques, do not get involved in an argument. Avoid confrontation. Do not get involved in a physical situation. Do not try to apprehend anyone even if you have had training in self-defence techniques. If you have had such training, only use it as a last resort to defend yourself. Your aim should be to defuse a potentially violent situation and reduce the risk of injury to yourself and other people. As soon as possible, contact the Police and leave apprehension to them.
